Industrial AI Corporate Leader of the Year Award Details

Eligibility:

To be eligible for the **Industrial AI Corporate Leader of the Year**, the nominated candidate must:

- Have a primary focus on operating in industrial markets or offering/incorporating AI solutions specifically tailored for such markets
- Have a history of partnering and/or collaborating with Industrial AI or Software companies.

Evaluation Criteria:

The Independent Selection Committee will choose the **Industrial AI Corporate Leader of the Year** based on the following:

- Financial & public market performance of their company
- Introduced or acquired new approaches, tools, and techniques that have advanced digital and AI transformation of industrial sector(s)
- The transformational potential of the AI innovation delivered
